## Rates

Villa rates are quoted in United States Dollars inclusive of all current taxes & Daily breakfast

Villa Rates are based on double occupancy per room per night, there are no deductions for single occupancy

Guests staying 20Dec - 10Jan (incl) must stay a minimum of 7 nights

Children rates are applicable between the ages 2 and 11 (inclusive). Age 12 and above will be considered as an adult

Infants under the age of 2 will only be charged for the Government Bed Tax of US\$8.00 per night. Infant cots are available free of charge and booked in advance

50% discount applicable for children between the ages 2 - 11 on meal supplements.

## Villa Occupancy Rules

Grand Pavilions (2 bedroom) maximum occupancy of 4

All other Villas maximum occupancy of 3 adults OR 2 adults + 1 child (12 years and below). A third bed is provided in the form of daybed

Complimentary baby cots available for infants below 2 years

Children over 12 years will be charged at adult room and meal rates

## Gala Dinners

All guests staying the minimum of 7 nights over the festive period will be provided with complimentary gala dinners over the christmas and new year festivities.

In the cases where the management allows guests to stay for less than 7 nights during the festive period, the following additional charges will be incurred for compulsory Gala dinners

Christmas Eve Dinner, Christmas Day lunch & Christmas Day Dinner - US\$250 per person (children aged 2-11 (incl) will have 50% discount)

New Years Eve Dinner and New Years day Champagne Breakfast - US\$225 per person (children aged 2-11 (incl) will have 50% discount)

## Honeymoon Complimentary offer (minimum 4 nights stay)

Fruitbasket, Romantic dinner (3 courses) and celebratory turn down service on first or second evening.

For guests staying 13 nights or more they are entitled to a complimentary blessing ceremony, with local photographer, ceremony on beach or private jetty, wedding cake, a bottle of wine, a private dinner in the villa or on the beach, a special turn down service with strawberries & cream & on departure a wedding album with a selection of 20 photographs.

## Anniversary Complimentary Offer

All guests celebrating Silver or Golden Anniversary will receive a bottle of sparkling wine and celebratory cake in the villa

## Scenic Air Transfer

Transfer is by domestic flight from the Male' International Airport to Hanimaadhoo Airport (45 minutes)

A speed boat journey of 45 minutes from the domestic airport to Manafaru Island

In line with international flight arrivals and departures both day and night transfers are available

Due to weather conditions, night transfer may not always be available. In which case, night arrival guests shall overnight in Male' and transfer provided the next day on the first available flight.

## Grand Pavilions Booking Procedure and conditions

All Bookings for the Grand Pavilions must be confirmed within 30 days after making the reservation by non-refundable deposit for the first nights accommodation

90 days prior to arrival, a further non-refundable deposit of 50% of the accommodation charge is required

30 days prior to arrival, full non-refundable payment of remaining accommodation charges is required (excluding clients with credit facility)

The Grand suite rate is applicable for up to 4 occupants including Room service Breakfast

## Check-in / Check out procedure

Check-in time is 1400hrs and check-out will be at 1200hrs (local time)

Where possible early morning arrivals may be able to check-in prior to 1400hrs on availability basis. To guarantee early check-in, pre-registration of previous nights accommodation is required

Day use of Villas and Suites until 1800hrs - 50% of the rates on basis booked (on guaranteed basis)

Use of Villas and Suites beyond 1800hrs - 100% of additional nights accommodation (on guaranteed basis)

## Cancellation / No Show Policy for all villa categories (except the Grand Pavilions)

### FESTIVE

Cancellation within 30 days from arrival : 75% of the invoice amount

Cancellation within 21 days from arrival : 100% of the invoice amount

One way transfer per person will also be charged

### PROMOTION

Cancellation within 14 days from arrival : 75% of the invoice amount

### PEAK

Cancellation within 7 days from arrival : 100% of the invoice amount

One way transfer per person will also be charged

No-shows and early departures will be charged at 100% of the invoice amount
